for the year ended 31 March 2019

The Otter Valley Association was established in 1979 as a civic amenity society covering the civil parishes of Budleigh Salterton, East Budleigh with Bicton, Otterton, Colaton Raleigh, Newton Poppleford and Harpford with Venn Otterv.

Its principal aims are:

- · To promote high standards of planning and architecture
- To educate the public in local geography, history, natural history and architecture
- To secure the preservation, protection, development and improvement of features of historic or public interest
- To conserve, protect and restore natural features of ecological or scientific importance.

Organisation

The OVA's activities are governed by a written Constitution, which sets out its objects and regulations. It is registered with the Charity Commission, and is subject to the legislation applicable to charities, in particular The Charities Act 2011.

A copy of the Constitution is always available on request and can be downloaded from our website www.ova.org.uk.

Management

The management and administration of the OVA is carried out by the Executive Committee (EC), which this year met ten times. This Committee normally consists of the Chairman, Vice-Chairman, Hon. Treasurer, Hon. Secretary, and up to twelve other members of the Association. Members of the Executive Committee, all of whom are Charity Trustees, are elected annually at the Annual General Meeting. The Committee includes representatives from each parish.

The names of those who served as Trustees during the year under review are listed elsewhere in this report. Much of the OVA's work has been carried out by sub committees or individuals who report to the EC but the Constitution makes it clear that the Executive Committee is responsible for all the decisions made on behalf of the Association.

It was my intent to print the names of all such volunteers in the newsletter, but am advised that I might be in breach of the dreaded Data Protection Act. So once again through this medium, to all the 72 plus, thank you all.

Tonight we will see a few changes in the Officers and the members of the Executive Committee: Penny Kurowski and Jon Roseway have completed their three years of office after carrying out superlative work as secretary and treasurer. Geoff Lake is standing down, also after three years, after producing for us, some excellent talks. The vacant positions have been nominated and seconded. Other positions remain as before.

The 2018, Xmas party exceeded all expectations of numbers and the Richter Scale of fun. This year we eagerly await a 'murder mystery' being tailor made for our delectation. We also look forward to our Ruby Anniversary party and later a farm visit as a follow up to the very successful one in 2015.

We reached the short list and at the prizegiving were delighted to be awarded second place. Congratulations to all concerned.

The Environmental Committee continue to do sterling work to arrest the spread and eliminate the dastardly Himalayan Balsam. With some success. there have been reports in some places of disappointed pluckers being unable to find any. However, they have not become complacent as the problem is so widespread. The annual litter pick attracted record numbers of participants and happened to coincide with a national litter pick campaign. The Planning Committee under the leadership of the indefatigable Nicola Daniel has continued to draw our attention to some of the more unfortunate applications and decisions of the EDDC Development Committee and also those of the Government Inspectors. This committee has done much work in contributing submissions to various consultative projects. Our treasurer's report shows an increase of 13% in our income. however expenditure has risen by 11%. Nevertheless we still have a healthy reserve. The walking group, in the year ending 31st March. recorded a remarkable total of 69 walks. This has involved a huge amount of organisation from initial conception to the dry runs to the actual walks. It is perhaps the walks for which the OVA is best known. Our Membership Secretary has been diligently processing every new application and has recorded an increase of 79 members in the last year bringing our total to 844 members. Well done to those who have been able to recruit new members

Although we had issued an open invitation to pay towards the transport of schoolchildren to the Pebblebed Heathlands, there were no applications last year. We have now put the matter on a more formal basis and have agreed to finance up the £100 for each application, up to a maximum of £1000 per annum. We have also removed the necessity for the visit to be to the heaths so that it can include farm visits. The schools will apply directly to us for this grant, in order for them to be aware of the source of such funding.

Finally I would like to thank the Executive Committee for the enthusiasm and support which they have given to me during the last year. This has resulted in valuable meetings, often running into overtime.

Membership Report

OVA membership increased by 79 new members, raising membership numbers to 844 by the end of the membership year.

The General Data Protection Regulation Act 2018 which came into force in May last year, has required some changes to how the OVA handles data, privacy and the cookies on the website. More details about these are available on the website, or on request from the membership secretary. The OVA is now tracking how new members hear about joining; walks, talks and publicity stands at local events prove effective at recruiting, interestingly with the website being the main source of application forms. As always though, word of mouth proves to be the best source of new members. If we each encourage one person to join in 2019, the OVA would become one of the biggest Civic Amenity Societies in England, strengthening its sway on both local and national matters.

Treasurer's Report

Income for the year was 13% higher in comparison to the previous year. Subscriptions, always our main source of income, increased slightly. The other major contributors were Gift Aid, book sales, and profit from our Talks programme and Christmas party. The large surplus from the party was unintentional and resulted from a much larger number of participants than expected.

Expenditure was up by 11% resulting in a small surplus for the year. The newsletter was by far the largest expense and increased by 9%. Significant investments were made in promotional goods such as badges and notepads as part of the recruitment campaign, and in display boards for Otterton church. There were no payments for schoolchildren's transport to the Pebblebed Heaths, but financial support for this project is expected to recommence in 2019. Donations to like-minded organisations were down, whilst admin costs were up.

Assets at the close of the financial year stand at £23,195 which includes a reserve fund of £12,496 held in an interest-bearing account.

I would like to thank Brian Leveridge for his assistance in preparing these accounts and ensuring that everything is in order.

Natural Environment

The OVA Himalayan Balsam (HB) project commenced in 2011 and has achieved its first target of effectively controlling infestation in the Colaton Raleigh brook. We are now making an important decision as to where we can expand into pastures new. Top of the wish-list is Bicton College grounds which have become heavily infested. Together with Clinton Devon Estates (CDE), we are working with representatives from the College, the Arena, and the Gardens to try to achieve a "Balsam-free Bicton". On 6th December, CDE gave volunteers a "thank-you" lunch at The Otterton Mill in Otterton. On 25th February 2019 there was the customary "feed-back" seminar at CDE HQ involving the various groups tackling HB. This again, provided a good opportunity for discussion of future strategy. We continue to investigate the possibility of employing a specific rust (fungus) to infect and impair the vigour of HB.

Following the excellent increase in volunteers to 25 in 2017, numbers slipped slightly to 19 in 2018. We would greatly welcome any member who would like to do something positive for the environment to join our dedicated group. In August, we erected a gazebo on the river bank at Otterton to inform the public of our activities and to encourage new OVA membership. A new pamphlet describing all about HB has been commissioned and will be available for distribution in spring 2019.

We have attempted to re-introduce Harebells to the Jubilee meadow (on the common, to the west of Budleigh beach) with seeds broadcast in the autumn and further sowings planned for this year.

Newly planted Scots pines (to reinforce the aging three original pines) which stand so prominently on the skyline east of Park Lane are thriving despite last year's dry summer.

The Annual Spring Litter-pick was held on Saturday 23rd March 2019. Turn-out, as always, was excellent, the weather kind and prizes were awarded by the Mayor Cllr. Alan Dent. This year, Geoff Porter has kindly agreed to take over the organisation of this event.

The NEC contributed to the OVA's response to the Landscape review, commissioned by Michael Gove, to update and reinforce the status of National Parks and AONBs, with particular emphasis on the special features of East Devon and Dorset.

Planning

I was hoping that I could give a positive report on planning for the last year as East Budleigh and Budleigh Salterton both had Neighbourhood Plans adopted and their local housing needs are on target. Also East Devon's house building rates are on target.

However, it seems that the pressure to build over-rides even the designated policies of our AONB and our Conservation Areas. EDDC planning officers, town and parish councils, the Appeals Inspectorate and even District Councillors give great weight to housing need. As a district councillor comments in an environmentally sensitive site

"Along with the Parish Council I believe this is a finely balanced application where the benefit of removing a dilapidated barn to provide sustainable accommodation just outweighs the potential harm to the environment and the wildlife. Therefore it has my support."

The Budleigh Salterton Town Council was incorrect as no additional accommodation would have been added to Budleigh Salterton's housing stock but nevertheless commented on a planning application

"On this occasion Members feel the benefit of additional accommodation in a sustainable location outweighs the potential harm to the conservation area."

The greatest disappointment to many members was the approval of an engineering works by just one vote on the Pebblebed Heaths. Another great disappointment was the interpretation by an Appeals Inspector of BS Neighbourhood Plan which allowed garden infill contrary to the NP policies. I have already written at length about East Budleigh and the development behind the High Street.

The OVA has lost count of the number of planning applications submitted by Ladram Bay to EDDC and not yet decided. What is holding it all up? However, the OVA will continue to comment on policies which are contrary to our constitution and that, if we make no comment it can be assumed that there will be no major impact on the environment. However, a planning application may cause a major impact to the neighbours so please, please send in your objections to EDDC if this is the case. And please continue to contact us if you are worried and need advice.

Walking with the OVA, 2018-2019 review

In the 12 months ended 31/3/19, 743 walkers have undertaken a total of 69 walks covering a total of 4,739 miles walked by members with an average of 10.8 attendees per walk. It is encouraging to see that there has been a marked increase in attendance since the start of 2019. We frequently hand out membership forms to new walkers and it is nice to see new faces again.

All this would not be possible without the group of walk leaders who I badger each quarter to ask them to lead a walk or two in up to 4 months' time, a feat of personal planning itself. Each walk has to be reconnoitered at least once to ensure paths are negotiable and where public transport is involved, timetables need to be checked. The walk team would like to express their thanks to these volunteers who put in several hours behind the scenes to ensure the day's walk goes without a hitch.

In the past year, our long-distance staged walk was the Devonshire Heartland Way which started in Okehampton and headed East. We have walked various routes on our local commons which seem to be particularly popular. We have visited various areas of Dartmoor, popped over to East Dorset to sample some offerings there, explored parts of our local coastal paths, headed along the Tiverton canal, visited the towns of both Ashburton and Colvton and walked some local favourites in our beloved Otter Valley.

The programme for the next quarter is in the new magazine and on the OVA website. Let's hope the weather is kind to us for we have some interesting walks planned, including some new offerings.
